The Future is Here, The Future is NIBRS!

As you may have heard, law enforcement agencies in the United States are slowly and steadily moving away from the 80+ year old Summary Uniform Crime Reporting system to the newer more robust National Incident-Based Reporting System, or NIBRS. This conversion brings about new challenges as antiquated manual reporting methods are replaced by more detailed computer-based technologies.

The days of simply tallying up the monthly number of larceny thefts on a Big Chief tablet and a #2 pencil are rapidly disappearing. To effectively anticipate crime, you need a source of data where all the points within an incident are connected and can be queried against each other to map out a true picture of an agencies overall crime. This is the belief of the FBI, and it is also the belief held by your Department of Public Safety.

National programs like the National Crime Statistics Exchange (NCS-x) are encouraging agencies across the country to move from their old Summary-based programs to Incident-based reporting. The Bureau of Justice Statistics is actively engaged with the FBI through NCS-x to identify and assist agencies to move to the future of crime reporting. This assistance includes not only funding sources but training and education for public, media and governmental entities that would have concerns regarding change.

Texas is working very closely with BJS and the FBI and we are planning the single largest influx of new NIBRS reporting agencies the state has ever seen, starting in 2015. The question is, what does YOUR agency need to make the switch?

Well, for starters, you will need a records management system that will be able to produce a NIBRS output. Since NIBRS is housed within your reporting system, the actual creation of the data is a breeze; the software does all of the work!

One plus is that many vendors of these systems already can do both Summary and NIBRS reporting, so if you are reporting Summary now, in some cases it is simply flipping a switch to go to NIBRS. DPS does have a stringent certification policy about NIBRS agencies and vendors, and even has a list of vendors who are already certified for NIBRS reporting (just email us and we'll be happy to show it to you!)

The certification process for new vendors (and their agency) includes a test of the computer file (to make sure the data is in its proper place and will be imported correctly), then the agency must report three consecutive months of both Summary and NIBRS. The NIBRS data is converted to Summary and the two reports are compared for similarity and accuracy. A 4% or less error rate for all three months will make you (and the new vendor) certified for NIBRS reporting in Texas.

For an already approved vendor, the process is even easier (as that vendor has already a proven track record with DPS) where we require only one month of Summary and NIBRS to compare, once that data is 4% or under in errors, bingo, you are a NIBRS reporting agency!

CRIME INFORMATION BUREAU (LPR)

DPS is in the process of standing up a statewide License Plate Reader file comprised of LPR reads submitted by contributing agencies across the state. LPR systems read and store license plate data from any vehicles that pass the camera, capturing date, time, and location when they do so. These cameras may be fixed, mobile, or transportable, and many are capable of capturing dozens of license plates simultaneously. One major law enforcement agency in Texas with only 30 of these LPR cameras generates roughly six million "reads" per month. By capturing and pooling this license plate data, law enforcement agencies contribute to an immensely powerful investigative tool that is instantly and widely searchable, providing enormous data sets for the locations of potentially millions of license plates over an extended period of time.

The DPS Texas License Plate Reader file would be accessible only to authorized law enforcement agencies via TLETS, and will contain only the license plate data, time and location stamp, and contributing agency information. Images or personally identifying information will not be supported. SEX OFFENDER REGISTRATION

Region Representation Vacancies

The Sex Offender Registration Bureau's Field Representative Section currently has two vacancies. This means that Region 5 (Panhandle) and Region 2 (Southeast) currently do not have a designated field representative. We are working on hiring new field representatives to cover the vacant regions. In the meantime, representatives from other regions will be assisting and conducting trainings for the counties and agencies located in Region 5 and 2.

Revised Sex Offender Registration Forms (Update on progress)

The revised CR-35 (Sex Offender Registration Form) is currently being printed and a formal release of the form is expected soon after. Significant changes to the form include:

- The form is legal size.
- The form will accommodate the reporting of all registration information that is captured by the Secure Sex Offender Registration web site.
- The "Verification" copy of the form will be replaced with a "Notification" copy of the form. (Verification and Update/Change of Status information will be submitted online).
- Offense reporting is enhanced to illustrate the type of offense (Texas Offense, Substantially Similar Offense, Court Ordered Offense, Board Ordered Offense, Extra-Jurisdictional Offense, etc.) the person is required to register for.

Local agencies that use in-house software or vendors to create Registration forms for their local registry/agency use should plan to make preparations to modify their current form(s) to the revised one. Once the revised forms are released, the previous version will become obsolete and a systematic phase out of the older forms will be initiated. SUBSCRIPTION SERVICE (TEXAS SOR)

The Department of Public Safety has created a notification system that allows the public to subscribe to e-mail notifications regarding database changes related to registered sex offenders. This system gives citizens an option to receive active notices on registrants they may have an interest in. This service is different than traditional publications in the sense that the person does not have to seek the information but rather the person is notified when changes are made on those registrants affected by the subscriptions they have. This utility is provided to the public free of charge and is available through the DPS sponsored Sex Offender Registration Web Site at https://records.txdps.state.tx.us/SexOffender/.

The Subscription Service is set up to allow the public to choose one or multiple subscriptions. Subscriptions are based upon geographical areas of interest, Institutions of Higher Education or unique registrants. Users may choose any of the following types of subscriptions:

<u>Address Subscription</u>: Subscribe to a particular address and notification will be e-mailed whenever a registrant moves within or out of the selected radius of that address. This will include if the registrant moves to another address within the selected radius.

<u>ZIP Code Subscription</u>: Subscribe to a zip code and notification will be e-mailed anytime a registered sex offender moves into, out of, or within this particular zip code.

<u>Higher Education Campus Subscription</u>: Subscribe to one or more campuses of higher education and notification will be e-mailed when an offender is reported to be enrolled or employed at that institution or when a registrant no longer is enrolled or employed at that institution.

<u>Individual Subscription</u>: Subscribe to a specific registrant and notification will be e-mailed whenever the registrant's address changes or the registrant is removed from the public web site.

E-mails are sent nightly and contain links to complete individual registration records within the Texas Sex Offender Registry that are affected by each subscription they are subscribed to. Subscriptions can be added/deleted at any time to allow users flexibility in managing the registrant population they may have interest in.

VIOLENT PERSON FILE (VPF)

Texas agencies can now enter records into the NCIC Violent Person file (VPF). The VPF is similar to the "Threat Against a Peace or Detention Officer" file with the main difference being that the "Threat" file is only viewable by Texas agencies. The VPF file will extend across state lines, in an effort to enhance officer safety. DPS recommends that any entries made in the Threat Against Peace Officer or Detention should be entered into the NCIC VPF file.

The File does not require hit confirmation and is designed to provide law enforcement officers with adequate warning regarding individuals who have had involvement in criminal activities or are known to represent potential danger to the public

An entry into the <u>Violent Person File (VPF)</u> should be made when at least one of the following criteria has been met:

- 1. Offender has been convicted for assault or murder/homicide of a law enforcement officer, fleeing, resisting arrest, or any such statute which involves violence against law enforcement.
- 2. Offender has been convicted of a violent offense against a person to include homicide and attempted homicide.
- 3. Offender has been convicted of a violent offense against a person where a firearm or weapon was used.
- 4. A law enforcement agency, based on its official investigatory duties, reasonably believes that the individual has seriously expressed his or her intent to commit an act of unlawful violence against a member of the law enforcement or criminal justice community.

VPF records have an unlimited retention period. A VPF record will remain on file indefinitely or until action is taken by the entering agency to cancel the record.

ELECTRONIC ARREST REPORTING (EAR)/LIVESCAN

DPS has never allowed resubmissions for corrections or to add additional charges on the livescan, but has not excluded the need to resubmit an exact duplicate if a response was not received. DPS has to change this procedure based off changes from FBI's Next Generation Identification (NGI) System. DPS is now requesting agencies to not resubmit if a response is not received. An agency will be required to check the CJIS Site to verify the arrest has applied to the Computerized Criminal History (CCH). If the arrest has not been applied to CCH after 4 hours, then contact DPS (call 512-424-5248). Please keep in mind if systems go down and are unable to process records, allow a minimum of 24 hours after systems are functioning normally before contacting DPS when a record has not been applied to CCH. When contacting DPS, DPS will verify if the prints have/have not gone through AFIS and let the agency know if they are able resubmit.

This change is critical and necessary because all duplicate submissions are now applying to FBI's rapsheet. This means if an agency submits the same record five times, FBI's rapsheet will display all five submissions. Note: This does not apply if a record has been rejected by DPS. If you have received the reject (MRJ) response, you may resubmit the corrected record without contacting DPS. To make corrections or add additional charges to an arrest that has been applied to CCH should be submitted through the CJIS Site (http://cch/txdps.state.tx.us) or by faxing 512-424-2476.

SENATE BILL 652: TEXAS DRIVER LICENSE RECORDS

Beginning Sunday, November 23, 2014, TLETS KR and DR responses will include Emergency Contact information if the record holder has provided this information to the Texas Driver License Division.

Transportation Code, Title 7, Subtitle B, Section 521.060, requires Texas DPS maintain in its files a record of the name, address, and telephone number of each individual identified by the holder of a driver's license or personal identification certificate as an individual the holder authorizes to be contacted in the event that the holder is injured or dies in or as a result of a vehicular accident or another emergency situation. This information is confidential and, on request, may only be disclosed as follows:

- 1. only to a peace officer in this or another state;
- 2. only if the peace officer is otherwise authorized to obtain information in the driver's license or personal identification certificate files of the department; and
- 3. only for the purpose, as applicable, of making contact with a named individual to report the injury to or death of the holder of the driver's license or personal identification certificate.

DATA CONTRIBUTORS (N-DEx)

Did you know that there were over 230 million records that have been submitted to N-DEx?

Within the N-DEx database, you will find a breakdown of where all of those records originated. They are broken down first by which state they were received from. The state of Texas has submitted almost 90.5 million records (or approximately 36% of total N-DEx records).

The numbers are then broken down by the data contributing agencies within that state. In the state of Texas, there are records from over 730 agencies. The agency breakdown list also provides information as to the type of data that those agencies have shared or are sharing.

To access this information, one would rest their cursor over the "Resources" tab from the main N-DEx search screen. A dropdown menu appears and the first option is "Data Contributors". Clicking on that will bring up a .pdf file. The document is long, but you can click on the state name to be taken to a listing of contributing agencies in that state.

This report is updated on a monthly basis, so the newly added contributing agencies will not be listed until the following update.
