Executive Order #8 (Grant Funding)

On September 5, 2019, Governor Abbott issued eight executive orders to help prevent mass shootings by increasing law enforcement's ability to respond to suspicious activity.

Order No. 8 stated:

"Beginning January 1, 2020, all future grant awards from the Office of the Governor to counties shall require a commitment that the county will report at least 90 percent of convictions within seven business days to the Criminal Justice Information system at the Department of Public Safety. By January 1, 2021, such reporting must take place within five business days."

DPS has historically recognized a combined statutory interpretation of 60 days for disposition reporting - 30 days for a conviction to be final and 30 days to report final dispositions. DPS confirmed that the order refers to reducing the submission time frame of the second 30-day period.

Effectively, the order requires counties to submit final dispositions within 37 days in year 2020 and within 35 days in year 2021 and beyond

Completeness Reports (Grant Funding)

The Texas Code of Criminal Procedure (CCP), Chapter 66, requires counties to report criminal history dispositions to the Texas Department of Public Safety (DPS). This information is used by law enforcement, judges, and many public and private employers to check criminal histories.

Counties must have an average of 90% or above on both adult and juvenile disposition completeness and maintain timely reporting of all information as required by state law in order for any unit of government or non-profit agency within the county to be eligible for Criminal Justice Division funding.

Disposition completeness percentage is defined as the percentage of arrest charges a county reports to DPS for which a disposition has been subsequently reported and entered into the CCH system.

County Dispositions Exceeding 37 Days

- DPS, as a part of its monitoring process, notifies the County Judge when a reporting agency does not comply with Texas Code of Criminal Procedure, Chapter 66.
- The State Auditor's Office found a decrease in court reporting within the 30 days as required by statute.

NON-REPORTABLE OFFENSES BY LAW ENFORCEMENT

- **Probation violation, parole violation, bond forfeitures or release of surety.**

NON-REPORTABLE OFFENSES BY LAW ENFORCEMENT JUVENILES ONLY!!!

Chapter 51.02 of the Family Code

(12) "Referral to juvenile court" means the referral of a child or a child's case to the office or official, including an intake officer or probation officer, designated by the juvenile board to process children within the juvenile justice system.

Chapter 58.001(c) of the Family Code

If the child is not referred to juvenile court within that time, the law enforcement agency shall destroy all information, including photographs and fingerprints, relating to the child unless the child is placed in a first offender program under Section 52.031 or on informal disposition under Section 52.03.

General Offense Character (GOC)

- Sec. 15.01. CRIMINAL ATTEMPT. (a) A person commits an offense if, with specific intent to commit an offense, he does an act amounting to more than mere preparation that tends but fails to effect the commission of the offense intended.
 - (d) An offense under this section is one category lower than the offense attempted, and if the offense attempted is a state jail felony, the offense is a Class A misdemeanor.
- When an offense is Criminal Attempt of (A), Criminal Conspiracy of (C), Criminal Solicitation of (S) or Criminal Solicitation of a Minor of (M), the offense will be reported using the appropriate GOC Code, the 8 digit offense code of the offense related to the crime and the Level and Degree will be reduced by one.

General Offense Character (GOC)

- **Example:**
 - **Arrested/Detained for Criminal Attempted Burglary of a Building**
 - **GOC will be “A”**
 - **Offense Code will be 22990002 – Burglary of Building**
 - **The level/degree will drop from State Jail Felony to Misdemeanor A**

Victim's Age

Chapter 66.102 (h) of the Code of Criminal Procedures

- (1) Section 21.02 (Continuous sexual abuse of young child or children), Penal Code;
- (2) Section 21.11 (Indecency with a child), Penal Code;
- (3) Section 22.011 (Sexual assault) or 22.021 (Aggravated sexual assault), Penal Code;
- (4) Section 43.25 (Sexual performance by a child), Penal Code;
- (5) Section 20.04(a)(4) (Aggravated kidnapping), Penal Code, if the defendant committed the offense with intent to violate or abuse the victim sexually;
- (6) Section 30.02 (Burglary), Penal Code, if the offense is punishable under Subsection (d) of that section and the defendant committed the offense with intent to commit an offense described by Subdivision (2), (3), or (5);
- (7) Section 20A.02 (Trafficking of persons), Penal Code, if the defendant:
 - (A) trafficked a person with the intent or knowledge that the person would engage in sexual conduct, as defined by Section 43.25, Penal Code; or
 - (B) benefited from participating in a venture that involved a trafficked person engaging in sexual conduct, as defined by Section 43.25, Penal Code; or
- (8) Section 43.05(a)(2) (Compelling prostitution), Penal Code.

Victim's Age

- **Enter whole years only from 00 to 99**
 - **If Victim is under 01 years of age then you will use 00 for the Victims Age and in the Offense Literal field put actual age in days, weeks or months (i.e. 6 weeks)**
 - **If Victim is over 99 years of age then you will use 99 for the Victims Age and in the Offense Literal field put actual age**

Domestic Violence (DMV)

- **Only report a “Y” in the Domestic Violence field if the offense meets the definition of Family Violence as defined in Family Code 71.004**

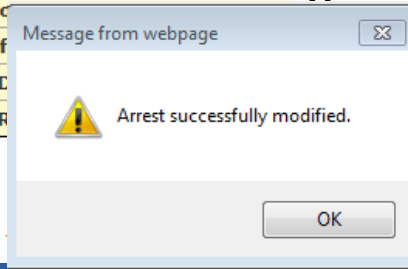

Arrest Segment Review

Can corrections to demographic information be made on the CJIS site?

- **No**
- **Corrections must be sent in by faxed or mail.**

Arrest Segment Review

Should a CR-43 be sent to DPS without fingerprints?

- **NO**
 - **DO NOT** send the CR-43/ CR-45 to DPS without fingerprints, or the CR-43 will be returned.

Arrest Segment Review

When is the Age of the Victim reported?

- **Refer to the Code of Criminal Procedures 66.102 (h)(1-8) for a list of offenses that require reporting of the Victims Age.**

Arrest Segment Review

Should a CR-43 be generated for an out of county warrant?

➤ **YES**

➤ The arresting agency should complete a CR-43 and fingerprint the offender. Forward the paperwork (prints included) to the warrant holding agency.

➤ **DO NOT SUBMIT TO DPS!**

****Prosecutor ORI determines completeness percentage****

Arrest Segment Review

Can an offender be arrested **BEFORE** they commit a crime?

- **NO**
 - When filling out the CR-43, make sure the offense date is **ON** or **BEFORE** the arrest date.

Referral/Identification Review

How are the 10 days determined for referring a juvenile to Intake?

- **Day 1 will be the day after the juvenile is fingerprinted.**
- **Count 9 more days (include weekends and holidays).**

Referral/Identification Review

What happens if the juvenile is not referred within 10 days?

- The CR-43J and prints must be destroyed. (Family Code Section 58.001(c)).
- The juveniles name must be blacked out of any offense report pertaining to that offense.

Referral/Identification Review

Is a CR-43J filled out when only interviewing the juvenile and not detaining them?

- **NO**
- **If a decision is made to file charges at a later date, a paper referral can be completed or they can be detained and complete a CR-43J form.**

Referral/Identification Review

Is a CR-43J submitted to the DPS at the time a juvenile is placed on a First Offender Program?

- **NO**
- **Hold the CR-43J until the juvenile completes the First Offender Program.**
- **If the juvenile fails the program and a decision is made to refer the case to intake, submit the CR-43J with a Referral Disposition Numeric of 226.**

Referral/Identification Review

The juvenile is detained for a new offense within 90 days of completing the First Offender Program and now the original case will be referred, how is this reported?

- **Submit the CR-43J with a Referral Disposition Numeric of 227 on the original case.**

Arrest Segment Review

What should be done if an offense code cannot be found?

- **Call the arresting officer/agency and ask for the statute/citation.**
- **Call the CJIS office and we will help with an offense code.**

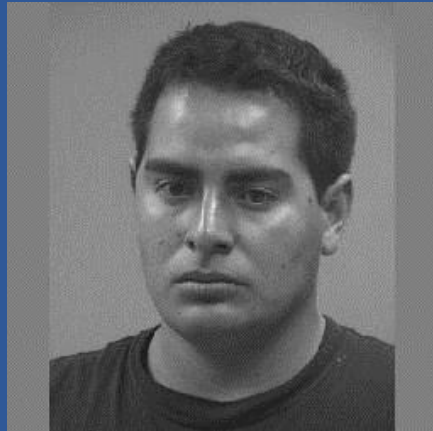
Livescan Information

- Criminal justice agencies must get approval from the Department to connect to the Department and must purchase a livescan device that appears on the FBI's IAFIS Certified Products List,

Livescan Responses

- **MAC – Accept:** A MAC message is used to advise the submitting agency of the acceptance of an arrest submission by the Texas DPS MBIS. This only means that the submission was accepted, but not processed yet.
- **MID – Identification:** The Texas DPS MBIS will return identification information for the fingerprints submitted upon successful processing through the MBIS system. This message will include the response “Hit” or “No Hit”. “Hit” indicates that the fingerprints matched an existing record in the DPS database, and the existing SID number is returned. “No Hit” indicates that the fingerprints did not match an existing record, and a new SID number has been assigned, if applicable based on the Type of Transaction (TOT) sent.

Livescan Responses

- **MNC – Noncritical Error:** The Texas DPS MBIS performs quality assurance on the submitted records' data. This message is used to advise agencies regarding errors in submission that have been corrected at the Error Resolution Terminal (ERT). You can use the information returned in this message to verify the corrected data. No resubmission of the record is needed, and a MID message will follow.
- **MRJ – Reject:** The reject message is used to advise the submitting agency of errors or problems with the record submitted to the Texas DPS MBIS. In most cases, the record will need to be corrected and resubmitted before it will be accepted and processed through MBIS. A MRJ message will return an error code which can be used to verify and correct the record before resubmission. The following are some common error codes and the action to be taken when received.

Livescan Responses

- FBI Responses
 - Submission Results – Electronic (SRE): This will contain a hit or no hit response from FBI. Search Result Findings = I is a hit response and N is a no hit response. If your livescan has the 2.070 RAP – Request for Electronic Rap Sheet populated you will receive a rap sheet with your hit responses.
 - Ten Print Transaction Error (ERRT): This response means the record did not process and it will supply an error message in the MSG field stating why the record did not process.
- DHS/ICE Response
 - Submission Results – Electronic (SRE): This will contain a hit or no hit response from FBI. Search Result Findings = I is a hit response and N is a no hit response. Hit responses will include information for up to the last five (5) encounters.
 - Ten Print Transaction Error (ERRT): This response means the record did not process and it will supply an error message in the MSG field stating why the record did not process.

Name Base Disposition (NBD)

- When a Prosecution or Court transaction passes edits but cannot be matched to an arrest, the CCH application places the transaction into the NBD file. When a new arrest is processed, the transactions in the NBD file are searched for matches. Any matching prosecution or court transactions are automatically submitted for processing.
- Records remain in the NBD file until: they match an arrest, are manually re-submitted by DPS analysts, or are deleted by DPS analysts at the request of the originally submitting agency.
- NBD on the CJIS website allows agencies to review their NBD transactions and either make a correction and resubmit it or close the transaction.
