CONS		Error #54	The possible causes of this error are: 1) The SID number being submitted has been consolidated by DPS with another SID number 2) The corrected SID number appears in the CONS field of the ER3 return record (position 152 – 159). The ER3 should be resubmitted using the new SID
CONF		Error #55	The possible cause of this error is that the ER3 is being submitted to update a juvenile arrest – juvenile prosecutions are to be reported using an ER4 and ER4J.
