

Message formats for Lost Gun Transactions

ELG -- Enter Lost Gun

Note: Entry formats are positional. All fields must be accounted for with a period even if the field is not mandatory. Field prefixes are not permitted. A "Cond. Set" means that if one of the fields is entered all of the fields in the set are required. A "One of Set" means that at least one of the fields in the set is required.

.<mod>	1-20		Gun Model Number. Alphanumerics with intervening blanks.
.<cal>	1-4	Required	Caliber. First character must be a non-zero numeric character. If only one character is used, the value must be greater than 2. Code as defined in the NCIC 2000 Code Manual.
.<typ>	1-2	Required	Gun Type. Code as defined in the NCIC 2000 Code Manual. If the first position contains the code P, S, or R, the second position cannot be blank. If the first position contains the code P, the second position cannot be A.
.<dol>	8	Required	Date of Loss in YYYYMMDD format.
.<oca>	1-20	Required	Originating Case Number. The only valid special characters are the hyphen and the space. Other exceptions are described in the NCIC 2000 Operating Manual.
.<lki>	9	Cond. Set (1)	Linkage Agency Identifier. Must be a valid NCIC-assigned ORI.
.<lka>	1-20	Cond. Set (1)	Linkage Case Number. The only valid special characters are the hyphen and the space. Other exceptions are described in the NCIC 2000 Operating Manual.
.<mis>	1-200		Miscellaneous. Free text.
.<noa>	1		Notify Originating Agency. Must be either Y or N.

MLG -- Modify Lost Gun

Note: To Delete a non-Mandatory field, send the MFC (prefix) with no data. Once modified, the record must adhere to the entry rules.

.TYP/<typ>	1-2	Gun Type. Code as defined in the NCIC 2000 Code Manual. If the first position contains the code P, S, or R, the second position cannot be blank. If the first position contains the code P, the second position cannot be A.
.DOL/<dol>	8	Date of Loss in YYYYMMDD format.
.OCA/<oca>	1-20	Originating Case Number. The only valid special characters are the hyphen and the space. Other exceptions are described in the NCIC 2000 Operating Manual.
.LKI/<lki>	9	Linkage Agency Identifier. Must be a valid NCIC-assigned ORI.
.LKA/<lka>	1-20	Linkage Case Number. The only valid special characters are the hyphen and the space. Other exceptions are described in the NCIC 2000 Operating Manual.
.MIS/<mis>	1-200	Miscellaneous. Free text.

XLG -- Cancel Lost Gun
